# **CPD Requirements for Pharmacists**

# General Pharmaceutical Council: Regulator

The General Pharmaceutical Council (GPhC) is the regulator for pharmacists, pharmacy technicians and pharmacies in Great Britain, their role is to assure and improve standards of care for people using pharmacy services.

### What do they do?

The GPhC sets the standards for professionals in the industry to enter and remain on their register. They are an active council and their responsibilities include:

- Set standards for education and training of pharmacists and pharmacy technicians.
- Maintaining a register of pharmacists, pharmacy technicians and pharmacies.
- Set the standards of conduct and performance that pharmacy professionals have to meet throughout their careers.
- Set the standards for CPD that pharmacy professionals have to achieve throughout their careers.

#### **CPD Requirements**

As a condition of registration, individual registrants must keep a detailed record of CPD and submit it to the Council when requested.

There must be a minimum of 9 CPD entries per year that reflect the context and scope of the registrant's practice, and record how heir CPD has contributed to the quality or development of their practice using the Councils CPD framework.
