CPD Requirements for Construction Professionals

Undertaking regular CPD is a requirement for a number of professional bodies, one such body is the Royal Institute of British Architects (RIBA) and their members must complete 35 hours of continued development each year. An organisation that can deliver CPD accredited training will be very desirable to ambitious industry professionals in this particular sector.

What are the benefits of CPD for construction professionals?

 The sector is continuously introducing new methods of construction / practise, so training and development are a crucial part in the future of the

industry. Therefore all professionals need to be on board and adapt to fast paced changes within their workplace.

 CPD enables employees to increase their skills and understanding of the industry whilst keeping up to date with all the latest regulation changes and any new product developments.

• CPD helps to keep professionals up to date with the latest innovations and products in the market, ensuring that they stay ahead of the competition.



• It helps individuals to strengthen their relationships with the professional bodies for and by working collaboratively with manufacturers will provide professionals working in the construction industry with additional support and guidance, thus enabling them to update their processes and adapt positively to changes in the workplace.

CPD Online

Online CPD is revolutionising the construction industry. Effective CPD helps to maintain, improve and broaden skills and knowledge. However, there is more to CPD than just keeping updated; the more self-aware people are, the more informed they will be and the more they will be able to reflect on their practice and decisions. Being able to apply these understandings is key to maximising learning, credibility, confidence and success. As technologies develop, the limitations will dramatically reduce and although fairly new at present, the likes of AI / VR and AR will also become effective and efficient ways of learning.

Professional Bodies

There are a large number of professional bodies within the construction industry, below we have listed a few examples:

Royal Institute of British Architects (RIBA) -

The Institute recommends that chartered members are obliged to undertake CPD hours per annum and these hours must come from the ten topics in the RIBA CPD Core Curriculum (two hours per topic per year). RIBA regularly monitor a random sample of chartered members' records to determine compliance.

Chartered Institution of Building Services Engineers (CIBSE) -

Members of CIBSE are required by the Code of Professional Conduct to maintain their professional competence. There are no minimum hours required to undertake but all members need to take ownership of their learning and development needs. Members are encouraged to log/record their CPD activities on a regular basis.

The Chartered Institute of Building (CIOB) -

The Institute recommends members a number of CPD hours to complete, but this is not compulsory. They look for evidence that members have gone through a process of further developing their needs to further knowledge. The CIOB has a member's portal which can be used to record CPD hours and can be accessed via the main CIOB website.

Royal Institution of Chartered Surveyors (RICS) -

All members are required to undertake learning in relation to the Global Professional and Ethical Standards at least once every three years. RICS offers CPD compliance guide where members can continually update their skills and knowledge to remain professionally compliant. All members (AssocRICS, MRICS and FRICS) must record their CPD activities online. RICS specify certain CPD hours that need to be carried out per year, see their website for more details.

The Institution of Engineering and Technology (IET) -

The IET has guidelines to CPD hours on their website which members should follow. At the IET they want members to embrace CPD on a dayto-day basis and have a career manager which can be used to record all CPD activities.
